## **EMPLOYEES**

Between Music will as employer process personal information that the employee has provided for the purpose of the employment relationship, including account number and civil registration number / cvr number., as long as the employee is in an employment relationship. The information is stored locked in a locker or behind password protection and access is limited to as few employees as possible.

Employees appear on the company's website with information about name, position and contact information without specific consent from the employee. If the employee's picture is desired on the website, express consent will be obtained.

When an employee resigns, it must be assessed which parts of an employee's personnel file are no longer needed, and what information must be stored for reasons of documentation to public authorities, potential disputes in the employment relationship, etc.

## **MEMBERS**

Between Music collects and processes personal information about the association's members. Only non-personally sensitive information is collected, as well as information on membership fees as a basis for maintaining membership.

#### **NEWSLETTER**

Between Music only collects personal information that you have voluntarily passed on yourself, e.g. via active subscription to newsletter with name and e-mail address. You can always unsubscribe from the Between Music newsletter again. When you unsubscribe from the newsletter, it happens automatically.

Between Music only uses your data in connection with our communication to you. At no time will your data be passed on or sold to third parties by Between Music. Between Music has entered into a data processor agreement with Wix.com to send out newsletters.

### PERSONAL DATA

Personal information is never given to third parties unless you expressly consent to this, and we do not collect personal information without you giving us this information yourself. To the extent that personal data about you is processed, you have the right under the Personal Data Act to be informed which personal data can be attributed to you. If it turns out that the information or data processed about you is incorrect or misleading, you have the right to demand that it be corrected, deleted or blocked. You can at any time object to information about you being processed. You can also revoke your consent at any time.

#### Statistics on visits etc.

When you visit the Between Music website or open our newsletter, your actions are recorded in Google Analytics. The information is displayed in a statistic that provides information about e.g. number of visits and average visit time. We use this data to optimize our communication to you.
